

## Revocation of Fire Certificate of Occupancy and Order to Vacate

RE:

132 WESTERN AVE S

Dear Property Representative:

Your building was inspected on April 18, 2018, for the renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code.

## A reinspection will be made on May 1<sup>st</sup>, 2018 or the property vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

## **DEFICIENCY LIST**

1. Class - SPLC 40.04 (5) - The owner of a building used for residential occupancy who is applying for their FIRST Fire Certificate of Occupancy, must complete the Department of Safety and Inspection Landlord 101 course, or other landlord training program approved by the Department of Safety and Inspections. The training must have occurred within the last two years and the owner must submit a certificate of attendance or provide verification of enrollment in the next scheduled class to the Fire Inspection Division-DSI. This requirement shall not apply to an owner who has held a Fire Certificate of Occupancy on another residential property in Saint Paul prior to April 30, 2009. Owners have a full calendar year to complete either class.

- 2. Exterior Back Door. SPLC 34.09 (4), 34.32 (3) Repair and maintain the door latch.- Replace missing door handle on back door.
- 3. Exterior Front window SPLC 34.09 (4), 34.33 (3) Repair and maintain the window glass.-Provide glass and screens or storm windows for all windows.
- 4. Exterior Garage SPLC 34.08(5), 34.32(3) All accessory structures including, but not limited to, detached garages, sheds and fences shall be maintained structurally sound and in good repair. Provide and maintain exterior unprotected surfaces painted or protected from the elements.-Repair roof, rotting wood and scrape and paint chipped and peeling areas.
- 5. Exterior SPLC 34.33 (3) Repair and maintain the door in good condition.-Repair or remove closer from front storm door.
- 6. Front Steps SPLC 34.09 (3), 34.33(2) Repair or replace the unsafe stairways, porch, decks or railings in an approved manner. This work may require a permit(s). Call DSI at (651) 266-8989.-Front steps to the public side walk are deteriorated. Please repair and maintain the front steps in an approved manner.
- 7. Interior Basement MMC 504.6 Provide, repair or replace the dryer exhaust duct. Exhaust ducts for domestic clothes dryers shall be constructed of metal and shall have a smooth interior finish. The exhaust duct shall be a minimum nominal size of four inches (102 mm) in diameter and installed in accordance with the mechanical code. This work will require a permit(s). Call DSI at (651) 266-8989.-Have a licensed contractor pull a permit and provide a code compliant dryer vent. Current one is not vented to the exterior.
- 8. Interior Bathroom SPLC 34.10 (7), 34.17 (5) Repair or replace and maintain the woodwork in an approved manner.-Repair or replace door with several holes.
- 9. Interior Living Room MSFC 605.6 Provide electrical cover plates to all outlets, switches and junction boxes where missing.
- 10. Interior Throughout MSFC 605.5 Discontinue use of extension cords used in lieu of permanent wiring.
- 11. Interior Throughout MSFC 605.1- All light fixtures shall be maintained with protective globes if originally equipped.
- 12. Interior Throughout MN Stat. 299F.362 Immediately provide and maintain a smoke detector located outside each sleeping area.-Repair disabled and non-working smoke detectors.
- 13. Interior Throughout SPLC 34.10 (6), 34.34 (5) Exterminate and control insects, rodents or other pests. Provide documentation of extermination.
- 14. Interior SPLC 34.33 (3) Repair and maintain the door in good condition.-Replace door on bedroom.

- 15. Interior MN State Statute 299F.50 Immediately provide and maintain an approved Carbon Monoxide Alarm in a location within ten (10) feet of each sleeping area. Installation shall be in accordance with manufacturers instructions.
- 16. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.
