Re: Ford Site, Combined Plat Application Process: City Decision Regarding the Preliminary Plat Aspect of the Combined Plat Review

Mr. Barranco,

Thank you for submitting your application processed September 23, 2019 for a combined plat for 966 Mississippi River Boulevard South, St. Paul, MN 55116 ("Ford Site") under Leg. Code § 69.405. Pursuant to Leg. Code § 69.405(2), the application was distributed to affected city departments for comments and required modifications. In addition, under departmental practice, your application was also distributed to relevant external government agencies for their review and comment. Due to the large number of responses and to streamline the revision process, we have combined all responses into a spreadsheet which is attached to and incorporated into this letter. Supplemental materials or letters from other agencies are also included as separate attachments.

Based upon these reviews, your preliminary plat is hereby approved as conforming with the City's subdivision regulations as well as the *City of Saint Paul Comprehensive Plan* and the *Ford Site Zoning and Public Realm Master Plan*; provided, the **corrections specified in the specified in this letter's attachments have been addressed.** After the corrections have been addressed with revisions or explanations to the satisfaction of the City, you may, pursuant to Leg. Code § 69.405(3) submit your application for final plat approval.

The City recognizes that formal infrastructure design has only just begun and there likely may be issues to be addressed as the project proceeds which could require adjustments to rights-of-way and/or new or revised easements. Please note that comments which do not directly impact the plat but pertains to future work phases of the project were also provided during the review of the preliminary plat. However, those comments will be provided to you under a separate letter to follow.

	N/A 1	See two redlined sets as other attachments. This plat is tied into the monument system at the northeast corner of section 17, T.28, R.23. This corner does indeed land on a manhole cover; a better reference would be the granite witness monument approximately 40 feet north of the corner.		
	2	The legal description for this is going to be changed <i>in toto</i> . For now, there are no comments regarding the legal until the new one is reviewed. Wait for Mike Winfield and Wayne Anderson, Ramey County, and see what they say or come up with.		
	3	Closures of the boundary and individual blocks were done by Mike Winfield & Greg Gund with the Ramsey County, refer to their redlines for comments and specifics.		
	4	The Hiawatha Park Addition No. 2 plat shows a right-of-way for Mound View Avenue. Not certain, but it appears this was never vacated. This small portion is adjacent to the Ford plat, southerly along the ¼ - ¼ line of SE 17. It doesn't line up with anything.		
	5	Pg. 1 – Surveyor's Certificate – change "Professional Land Surveyor" to "Licensed Land Surveyor" (per Ramsey County Manual of Guidelines For Subdivision Plats, June 2017 pg. 16) – <i>This comment referred to old copy of guidelines</i> .		
		Pg. 2 – Ford Parkway not identified as CSAH 42. Has County Hwy authority been notified as directed by MS505.03 Subd.2?		
		Pg. 2 & 3 – Our records show that the Center of Section 17-28-23 is a 2.5" Brass Disk, not a 1/2" iron pipe as indicated. Field reconnaissance confirmed this to be the case.		
	9	Pg. 3 – "HIAWATHA PARK ADD. NO. 2" is misspelled Pg. 5 – Under INSET G, should be corrected to read "(SEE SHEET 12 OF 14)" Pg. 6 & 7 – Is additional ROW being granted to Ford Parkway going to County or City?

All city storm sewer, sanitary sewer, and stormwater management systems located outside of Public Rights-of-Way need to be located in easements shown on the plat and recorded at County. 	CONSTRUCTION		Overall the plat is what was expected for the configuration of space. Although the calculations from Ryan with the overall quantity of parkland to be dedicated to the city is consistent with what the Department has calculated, we need to understand how the net quantity of parkland from the land platted in Outlots A, D, F and G is part of a formal agreement with Ryan. The outcome of that formality would result in the total dedication for each of the parks to be: Outlot A: 2.4 Ac (2.4 Ac Net Parkland + 1.2 Ac Stormwater Utility) Outlot D: 1.6 Ac Outlot F: 4.8 Ac (4.8 Ac Net Parkland + 1.6 Ac Stormwater Utility) Outlot G: 1.5 Ac City stormwater utility boundaries will be defined using an engineering basis that evaluates the extent based on a significant (100-year is current understanding) rain event and will not count toward the total acreage of the parkland for dedication calculation purposes.
			The labeling of the entirety of Outlots A and F as having utility and drainage easements over them is something that is of concern. The blanket easement for public utilities should be described to limit the property rights dedicated in the plat to either "drainage easement" or "stormwater retention pond easement" so that other public and private utilities don't have the right to locate their facilities anywhere in the outlot and we don't have to contact anyone but PW/Sewers when it comes to decertifying, adjusting, shrinking, terminating or replacing the blanket easement with a new easement covering only the stormwater pond after it's built. For now, please change labels for Outlots A, D, F, and G to all read "Park" and adjust other outlot labels accordingly. The City will follow up if easement language needs to be adjusted.

^{*}Note from PED: As of October 18, 2019, the AUAR for the Ford Site Development has not yet been adopted, but states that for Bohland Ave from Mississippi River Boulevard to Finn street, "a vehicular capacity perspective, this segment does not need to be a three-lane configuration. Removal of the center two way left-turn lane would allow for additional on-street parking, enhancement of other facilities (i.e. bike lanes or sidewalk space), and/or a reduction in overall cross-section/right-of-way need." If the AUAR is adopted before the final plat is approved, the change from 80' to 70' could be considered. Otherwise Bohland must be platted with an 80-foot right-of way west of Cretin in conformance with the Ford Site Zoning and Public Realm Master Plan.
