Please accept this summary as evidence of my personal and professional commitment to the success of this project at 1179 East 7th Street in Saint Paul, Minnesota.

Over the past 25+ years I've been involved in fundraising for many companies and organizations, ranging from start-ups to sophisticated mergers and acquisitions, both in the private and public sectors, plus there are numerous non-profits that have benefitted from my efforts. In Minnesota those endeavors have included a company I was a co-founder of that was acquired by Northern States Power, allowing me to become a Vice-President of the utility that ultimately became Xcel Energy. I was also part of fundraising for a large church in the north metro that has grown from 1,000 members to over 25,000 members on six campuses. While residing in the Twin Cities metro, I was also involved with a number of recovery related organizations, founder of one and a board member of a fast-growing recovery program for teens and adults.

Over the past fourteen years, my wife and I have led an organization doing work in Haiti, educating 1,400 students daily, creating more than 100 micro-enterprises, and recently opened a quarter million-dollar medical center to serve the local residents. During our time there we've been successful in raising more than \$17 million USD for that work.

In order to stimulate additional interest, I've recently added a local fundraising expert — Christy Morrell-Stinson — to my team of professionals, she will be focused on this project, in addition to working on another larger scale economic development project in Brooklyn Center, MN. She's been instrumental in developing the Opportunity Collaborative focused on that building (The Brooklyns Building) and the surrounding neighborhood.

I'd like to offer an overview of a few of the many benefits this Eastside Community Center project will deliver to the neighborhood:

- Substance Use Disorder programs Intensive Outpatient Programs, AA & NA meetings, plus professional counseling services.
- Music education both instrumental and vocal opportunities for the youth.
- Legal Services income-based legal services for those who are struggling to find suitable representation.

- ESL English as a Second Language courses will be offered to the immigrant communities in the neighborhood.
- Job Preparedness and Job Readiness working with SCORE, services delivered will include proper resume creation, basic computer skill training, and overall guidance for those in the program.

The agreement Kenneth Udoibok signed with Global Impact Partners in early August offers significant services, including campaign leadership and development, marketing services and material development, donor research, donor cultivation, as well as other related services.

I'm pleased to know that Kenneth and his team have already invested more than \$60,000 in the purchase and ownership of the building. The historical value of the building is significant and the ability to provide services in a neighborhood that's starving for attention, is a very worthwhile cause for us to work on and then celebrate success.
