Thank you for the opportunity to comment on the above project. It has been reviewed pursuant to the responsibilities given the State Historic Preservation Officer by Section 106 of the National Historic Preservation Act of 1966 and implementing federal regulations at 36 CFR 800.

Thank you for providing additional information on March 2, 2021, indicating that there is no new construction planned on these parcels at this time. Based on available information, we conclude that **no properties** listed in or eligible for listing in the National Register of Historic Places will be affected by this project.

Because these properties are within the statutory boundaries of the Capitol Area Architectural and Planning Board, we suggest you consult with the Board, as part of the Section 106 review process.

<u>575 Park Street</u>: the property has been a vacant building since 11/13/2007. The PO has had two code compliance inspections done, the last one in 2017 which has expired, and has done nothing to bring the property up to code. The City does not have any knowledge as to the owner's intentions which is why public hearings have been scheduled. At the legislative hearing, the hearing officer can refer the matter to be reviewed by the Capitol Area Architectural and Planning Board for review. If the owner does not show up for the legislative or council public hearings, the hearing officer can recommend the building be razed.

<u>595 Park Street</u>: the property has been a vacant building since 11/21/2008. The PO has had two code compliance inspections done, the last one in 2017 which has expired, and has done nothing to bring the property up to code. The City does not have any knowledge as to the owner's intentions which is why public hearings have been scheduled. At the legislative hearing, the hearing officer can refer the matter to be reviewed by the Capitol Area Architectural and Planning Board for review. If the owner does not show up for the legislative or council public hearings, the hearing officer can recommend the building be razed.

Both properties are owned by Viggco LLC, 86 Spruce Street, Mahtomedi MN. It should be noted that the PO is not maintaining the properties as the City has issued numerous orders to mow the lawn and shovel the snow. The City has also boarded the buildings due to vandalism.

The legislative hearing for both properties is scheduled for Tuesday, April 27, 2021. The Council public hearing is scheduled for May 26, 2021.
