The City Council will have the final authority to grant or deny the license.

This letter is to inform you of the status of the review of your recently submitted license application. At this time the **Department of Safety and Inspections cannot process your request for the Entertainment (B) or Liquor Outdoor Service Area (Patio) licenses** due to your failure to provide the required petition of support. Please contact DSI Inspector Ross Haddow at 651-266-9143 with questions about obtaining these licenses.

Our review of your application for the above referenced *indoor alcohol sales/service licenses with <u>no entertainment</u> is in process. Notification has been sent to the community organization and neighbors for the area in which you intend to operate giving them until Friday, May 7, 2021 to voice concerns to your application. Enclosed find an affidavit listing conditions DSI recommends be placed on this license. If you accept these conditions, please sign and return the affidavit. If you want to oppose placement of any of the conditions on the license, or have any questions, please contact DSI at one of the numbers referenced below so that we may explain your options.*

If no objections are received, and you have returned a signed affidavit, your license will be forwarded to the City Council for review and if approved by Council could then be issued (pending any requirements not completely met). If objections are received a hearing will be scheduled before a legislative hearing officer. You will receive notice of the time, place and date of the scheduled hearing from the Legislative Hearing Officer. At that hearing, the hearing officer will take testimony from all interested persons and will make a recommendation to the City Council as to whether the license(s) should be approved or be referred to an administrative law judge for further review. The City Council will have the final authority to grant or deny this license application.

Requirements including the following must be met prior to the issuance of your licenses:

- Sign and return one copy of the enclosed license condition affidavit acknowledging the conditions that will be placed on your license(s). A return envelope has been included for your convenience.
- Obtain all necessary building and/or trade permits related to any construction work associated with the establishment of this use, and all required inspection approval(s) related to these permit(s). Only licensed trade contractors authorized to perform work in that trade (e.g., plumbing, electrical, ventilation, etc.) may obtain permit(s) and/or perform work in such trade.
- Obtain final DSI Zoning Division approval of your proposed method of operation by contact DSI Zoning Inspector Farhan Omar at 651-266-9089 / Farhan.Omar@ci.stpaul.mn.us if you have not already done so.
- Provide proof of having obtained a restaurant license from the Minnesota Department of Health (MDH), who may be contacted at 651-201-4500 for information about their licensing process.
- Contact DSI License Inspector Ross Haddow at 651-266-9143 to schedule the required in-house review of DSI's Liquor License Manual and your last 3 years personal State/Federal tax returns.
