Placing the classification titled Lead Victim Witness Coordinator in the unclassified service pursuant to Section 12.03.2(H) of the Charter.

THE COUNCIL OF THE CITY OF SAINT PAUL DOES ORDAIN.

SECTION 1. That it is appropriate and desirable to place the position titled Lead Victim Witness Coordinator in the unclassified service.

SECTION 2. That pursuant to Section 12.03.2 (H) of the City Charter, such positions shall be established in the unclassified service of the City of Saint Paul by ordinance with the consent of the Civil Service Commission.

SECTION 3. That appointment to Lead Victim Witness Coordinator shall be made by the City Attorney.

SECTION 4. This ordinance shall take effect and be in force 30 days from and after its passage, approval, and publication, including by the Civil Service Commission.
