I spoke with Greg from GTS HVAC. He said that the permit for the new RTU is all set. (Laura, you probably remember our email before about taking care of that RTU first because the make up air unit is not in stock and it takes time to get it.) He's not sure why the RTU permit is not showing up. The permit for the make up air is still in process.

Please keep in mind that we began this process in April and we have been trying to expedite it every step of the way (estimates, paperwork, grant application, etc) but the timeline is out of our control. It sounds like you would like to see the make up air complete at the inspection on August 17th--and we would love that too--but it may not be done by then because of factors out of our control--permit process, ordering unit and parts, etc. If you would like, I can update you when I hear more about dates for the make up air and then we won't need to waste your time. Also, GTS HVAC said that typically when the work is finished they contact the inspector. In this case, why is the inspection being scheduled before the work is complete?

When you do come for the inspection, if you would like to see any paperwork, please let us know ahead of time. We keep the paperwork at home because, obviously, if there were ever a fire and the paperwork was at Thai Street Market that would be a problem.
