- 1. 618 Unit 1 Access SPLC 34.19 Provide access to the inspector to all areas of the building.
- 2. 618 Unit 1 Windows SPLC 34.09 (4), 34.33 (3) Repair and maintain the window in good condition. -The window in the left bedroom does not stay up and slides down.
- 3. Exterior Back Stairs SPLC 34.09 (3), 34.33(2) Repair or replace the unsafe stairways, porch, decks or railings in an approved manner. This work may require a permit(s). Call DSI at (651) 266-8989. The back-exterior wood stairs leading to the second level has sections that the stringers are not properly to the post. There are joist hangers that are not properly secured to the ledger board. Provide documentation from the engineer.

- 4. Exterior Guardrail SPLC 34.09 (3) 34.33 (2) Provide an approved guardrail with intermediate balustrade or rails 6 inches or less apart. This work may require a permit(s). Call DSI at (651) 266-8989.-There is a section of the guardrail for the stairs leading to the second floor that is cracked, warped and damaged.
- 5. Exterior Parking Surface SPLC 34.08 (7) All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-8989.-The concrete parking surface behind the building is in disrepair.
