WHEREAS, on February 17, 2021, the City Council of the City of Saint Paul adopted Council File #RLH AR 20 -73, said Resolution being the memorialization of an appeal to a Property Clean Up during January 16 to 31, 2020. (File No. J2016A, Assessment No. 208524); and

WHEREAS, the property at 382 Pierce Street, being described as: Milham Park, Ramsey Co., Minn. Lots 18 and Lot 19 Blk 3, with the property identification number 33-29-23-41-0107 was assessed an amount of \$478; and

WHEREAS, the Legislative Hearing Officer recommended that the City Council ratified the assessment and payable in one installment: and

WHEREAS, the Saint Paul City Council considered the Legislative Hearing Officer's recommendation in this matter; and
