**Staff Comments**: Solid Waste program policy currently dictates that an Unoccupied Dwelling Registration Form needs to be submitted and approved by Solid Waste program staff in order for service to be stopped at the property. Therefore staff recommends approving the assessment in full. The property owner has had ample notification that they were being billed for garbage as all invoices, notices of nonpayment, and assessment notices from the city were being sent to the property owner.
