**Staff Comments:** Hauler records show that the property owner did not make a payment during Quarter 4 2021. However, it does appear that the property owner did submit a vacancy hold from 7/15/2021 - 11/30/2021. The property owner was fairly credited for this time period. However, the hauler is requesting that staff remove the assessed amount of \$33.67 as a courtesy. Therefore, staff recommends removing the assessment.
