Stated Reason for Appeal (if given): Property owner stated that since they did not own the property until January 2022, they should not be required to pay the assessment.

**Staff Comments:** Hauler records show that there was garbage service provided to the property during the Quarter 3 2021 service period. The Quarter 3 2021 invoice was unpaid and therefore sent to the city as a pending assessment. As property owners are responsible for any pending assessments on their property, staff recommends approving the assessment.
