WHEREAS, the City Council's Legislative Hearing Officer has reviewed an appeal of this assessment and developed a recommendation for the City Council with respect to this assessment; and

WHEREAS, a public hearing having been conducted for the above improvement, and said assessment having been further considered by the Council and having been considered financially satisfactory; Now, Therefore, Be It

RESOLVED, that pursuant to Chapter 14 of the Saint Paul City Charter, said assessment is hereby ratified and reduced from \$480 to \$240, provided owner posts no dumping, video surveillance signs, and motion lights by September 6, 2022 and public hearing continued to February 15, 2023 and if no same or similar violation(s), will reduce from \$240 to \$100 as there was no subsequent violation.
