Approving the application with conditions, per the Deputy Legislative Hearing Officer, for Slate Billiard Club LLC (License ID #20230000170), d/b/a same, for a Pool & Billiard Hall license located 755 Prior Avenue North, Suite #002A.

WHEREAS, Slate Billiard Club LLC (License ID #20230000170), d/b/a same, located at 755 Prior Avenue N Suite #002A, has applied for Class N license for a Pool & Billiard Hall license; and

WHEREAS, a notification regarding the license application was sent from the Department of Safety and Inspections to the affected neighborhood for the period of February 15, 2023, to March 2, 2023; and

WHEREAS, during the notification period, objections were received which triggered the hearing and a hearing was held on March 6, 2023; and

WHEREAS, the objections were related to parking and nuisance activities; and

WHEREAS, in response to the concerns raised, the licensee has agreed to work with the city to comply with the necessary requirements to minimize nuisance activities that would disturb the surrounding residential neighborhood; and

WHEREAS, after conducting the hearing and considering the testimonies and evidence, the Legislative Hearing Officer recommends that the application submitted by Slate Billiard Club LLC (License ID # 20230000170), d/b/a same, for a Pool & Billiard Hall license, located at 755 Prior Avenue N Suite #002A, be approved with the following condition:

1. License holder acknowledges that under Section 322.03 of the Saint Paul Legislative Code this establishment shall be closed between the hours of 12 a.m. (midnight) and 7 a.m.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Saint Paul hereby approves this license application with the aforementioned agreed-upon condition and that there are no grounds to deny approval of the license.
