ECed again 8/15/22 (under appeal). Both the original SAO photo and 8/3 photo show sidewalk vegetation, but 8/15 photo shows back of house??? Inspector notes say 8/15 vegetation not cut (but no photo of it, just house). 8/29 reinspection says "found small amounts of OHV, closing file".
