## Legislation Text

Approving the application of Thai Cultural Council of Minnesota for a sound level variance in order to present amplified sound on May 27 and 28, 2023 at 75 Rev. Dr. Martin Luther King Jr. Blvd. - MN State Capitol. WHEREAS, Chapter 293 of the Saint Paul Legislative Code was enacted to regulate the subject of noise in the City of Saint Paul; and

WHEREAS, §293.09 provides for the granting of variances from the sound level limitations contained in §293.07, upon a finding by the City Council that full compliance with Chapter 293 would constitute an unreasonable hardship on the applicant, other persons or on the community; and

WHEREAS, Thai Cultural Council of Minnesota, represented by Farah Meenakanit, Project Coordinator, who has been designated as the responsible person on the application, has applied for a variance, for 85 dBA at no specified distance, to present amplified sound for the Minnesota Songkran Festival at 75 Rev. Dr. Martin Luther King Jr. Blvd. - MN State Capitol.; and

WHEREAS, applicant has requested a variance for the hours of 10:00 a.m. to 9:00 p.m. with a pre-event sound check at 8:00 a.m. on Saturday, May 27 and Sunday, May 28, 2023 for the Minnesota Songkran Festival; and

WHEREAS, if applicant is not granted a variance applicant will not be able to present amplified sound at 75 Rev. Dr. Martin Luther King Jr. Blvd. - MN State Capitol.; and

WHEREAS, the Department of Safety and Inspections has reviewed the application and has made recommendations regarding conditions for the variance. Now, therefore, be it

RESOLVED, that the Council of the City of Saint Paul hereby grants a variance to Thai Cultural Council of Minnesota, subject to the following conditions:

- 1) The Variance shall be for the hours of 10:00 a.m. to 9:00 p.m., with a pre-event sound check at 8:00 a.m. on Saturday, May 27 and Sunday, May 28, 2023, for the Minnesota Songkran Festival.
- 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA at 50 feet from all sound sources
- 3) The applicant shall provide personnel and equipment who shall provide continuous sound level monitoring at each sound mix during the hours of the variance.
- 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:00 p.m. on May 27 and 28, 2023, the event dates.

FURTHER RESOLVED, that any violations of the conditions set forth above on the May 27 and 28, 2022 dates may result in denial of future requests for the grant of a noise variance, in addition to any criminal citation which might issue.
