- Complete removal of all illegal wiring, receptacles, fixtures and equipment.
- Complete rewire of home to today's (2020 NEC) electrical code requirements.
- Complete demo of all Knob and Tube wiring in home.
- Complete removal of all existing fixtures, boxes, piping in basement and throughout home.
- Complete replacement of fuse panel with 200A 42 Space Eaton CH Copper Surge electrical panel to accommodate for circuits in home and future expandability.
- Complete removal and replacement of double meter socket in favor of a meter socket with disconnects for a single dwelling home.
- Lighting and general use circuits in bedrooms, hallways, living and common areas.
- Fulfillment of all circuit requirements in the Kitchen, Bathrooms, Dining, Laundry, common areas and exterior of home.
- Installation of outlets, lighting and switching in all required areas of home and rooms with desired locations added.
- Installation of Customer supplied fixtures for all lighting locations in home, ceiling fans, recessed lighting and or specialty fixtures.
- Installation of Fan brace boxes in all bedrooms, living and common areas where a fan can be installed in the future.
