Your building was re-inspected for the Fire Certificate of Occupancy on October 3, 2022. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected immediately. A reinspection will be made on November 18, 2022 at 10:30 AM.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

1. Exterior - 591-1, 596-98 - SPLC 34.09 (3), 34.33(2) - Repair or replace the unsafe stairways, porch, decks or railings in an approved manner. Every outside stair, porch and deck shall be constructed safely and shall be capable of supporting imposed loads as determined in the building code and shall be kept in a professional state of maintenance and repair with proper anchorage. This work may require a permit(s). Call DSI at (651) 266-8989.-Exterior stone Steps on the stairway leading to 596-1 and 596-598 need repair.
2. Exterior - unit 604 - SPLC 34.09 (3), 34.33(2) - Repair or replace the damaged handrail in an approved manner. This work may require a permit(s). Call DSI at (651) 266-8989.- Railing in front of unit 604 is loose at the bottom of steps
3. Interior - Throughout - MSFC 1104.5.3, 1008.3.5 - Provide and maintain an approved emergency lighting system.-Not working the 2nd floor of 596-98. Have all em. lights tested.

4. Interior - MSFC 505.1 - Provide address numbers at least four (4) inches in height.-Have unit doors posted with unit numbers in 602 and 596-98.
