This is to confirm that at the Legislative Hearing on May 10, 2022, Legislative Hearing Officer Marcia Moermond recommended that the City Council **grant to June 10, 2022 for the semi-truck to have current license tabs, and to August 1, 2022 for compliance with removal of the vehicle.**

The City Council Public Hearing is scheduled for Wednesday, May 25, 2022 at 3:30 pm. in room 300 City Hall. If you are contesting Ms. Moermond's recommendation, you may appear in person or send written testimony to be added to the record to legislativehearings@ci.stpaul.mn.us or by voicemail at 651-266-6805. **Should you wish to address Council directly but not appear in person, you must register in person by noon on the Tuesday immediately prior to your Public Hearing here: <https://www.stpaul.gov/departments/city-council/city-council-public-hearing-live-testimony>.** If you don't wish to contest, no further action is needed and the Council will proceed with Ms. Moermond's recommendation above.

After the May 25 Public Hearing, Ms. Moermond will review this case under two new resolutions:

1. a June 14, 2022 Legislative Hearing at 11:00 a.m. to determine if you have abated the nuisance(s) listed above on deadline pertaining the tabs. The City Council Public Hearing for that will be scheduled for Wednesday, June 22, 2022 at 3:30 pm. in room 300 City Hall.
2. a August 2, 2022 Legislative Hearing at 11:00 a.m. to determine if you have abated the nuisance(s) listed above on deadline pertaining to the removal of the semi-truck. The City Council Public Hearing for that will be scheduled for Wednesday, August 10, 2022 at 3:30 pm. in room 300 City Hall.

You are welcome to attend any of these hearings; please let our office know so we can call you in to participate. If you are contesting Ms. Moermond's recommendation from the June 14 or August 2 hearings, you may appear in person or send written testimony to be added to the record to legislativehearings@ci.stpaul.mn.us or by voicemail at 651-266-6805. **Should you wish to address Council directly but not appear in person, you must register in person by noon on the Tuesday immediately prior to your Public Hearing via the link above.**
