All understandings must be set forth in writing. No verbal understandings will be followed.

- 1) Remove 1 layer of roofing shingles, nails, and haul away debris.
- 2) Inspect for rotten wood prior to install. Additional charges may apply to repair rotted decking to meet code requirements.
- 3) Install Ice & water shield throughout valleys, including new valley, tin in color of Brown
- 4) Install 15# felt to ensure better water penetration barrier.
- 5) Install drip edge throughout house except where gutters are present, in the color of Brown
- 6) Install Flashing as needed.
- 7) Install Owens Corning Duration Architectural shingles in color of Dark with matching ridge cap.
- 8) Install Ridgecap & cap old vent on upper attic. Install Brown Cap Louvers over vents in kneewall areas.
- 9) Mail warranty & lien waiver upon completion.
- 10) Price includes labor, material, taxes, clean up, permits if needed.
- 11) Replace Roof Decking as needed on garage.
- 12) Install Aluminum Fascia on garage only, in color of white.
- 13) Homeowner responsible for take down & install of satellite dishes, basketball hoop, & security cameras.
- 14) BEI to wrap Double Garage Door & Garage Entry Door in Aluminum coil color white.

Work not to be done: Painting, staining, electrical, plumbing, landscaping, any work not listed above.

Purchaser understands and agrees that if this contract is cancelled, the Purchaser shall pay the Contractor 25% of the total of the contract and all its change orders in addition to restocking fees and special material costs incurred as damages for the breach of this contract. In the event of payment default, Purchaser agrees to pay reasonable attorney's fees and costs incurred, whether or not court proceedings are instigated, in addition to other sums you agree to pay the Contractor for the reasonable costs of enforcement or collection, and/or if in the event it is necessary to institute legal proceedings. Purchaser understands and agrees that if this contract is cancelled and materials have already been ordered there will be a restocking charge added to the cancellation fee. Purchaser understands and agrees that if the purchaser changes color, brand, etc., after the original material has been purchased a restocking charge will be added to the total contract price. Any unpaid balances will be due upon substantial completion. Any unpaid balances will be charged at the rate of 1.5% of the unpaid balance.

IN THE EVENT THIS OFFER TO CONTRACT IS NOT ACCEPTED BY CONTRACTOR, ANY PAYMENT MADE HEREUNDER SHALL BE REFUNDED TO THE PURCHASER(S). THIS PROPOSAL SHALL BE NULL AND VOID AND OF NO EFFECT. 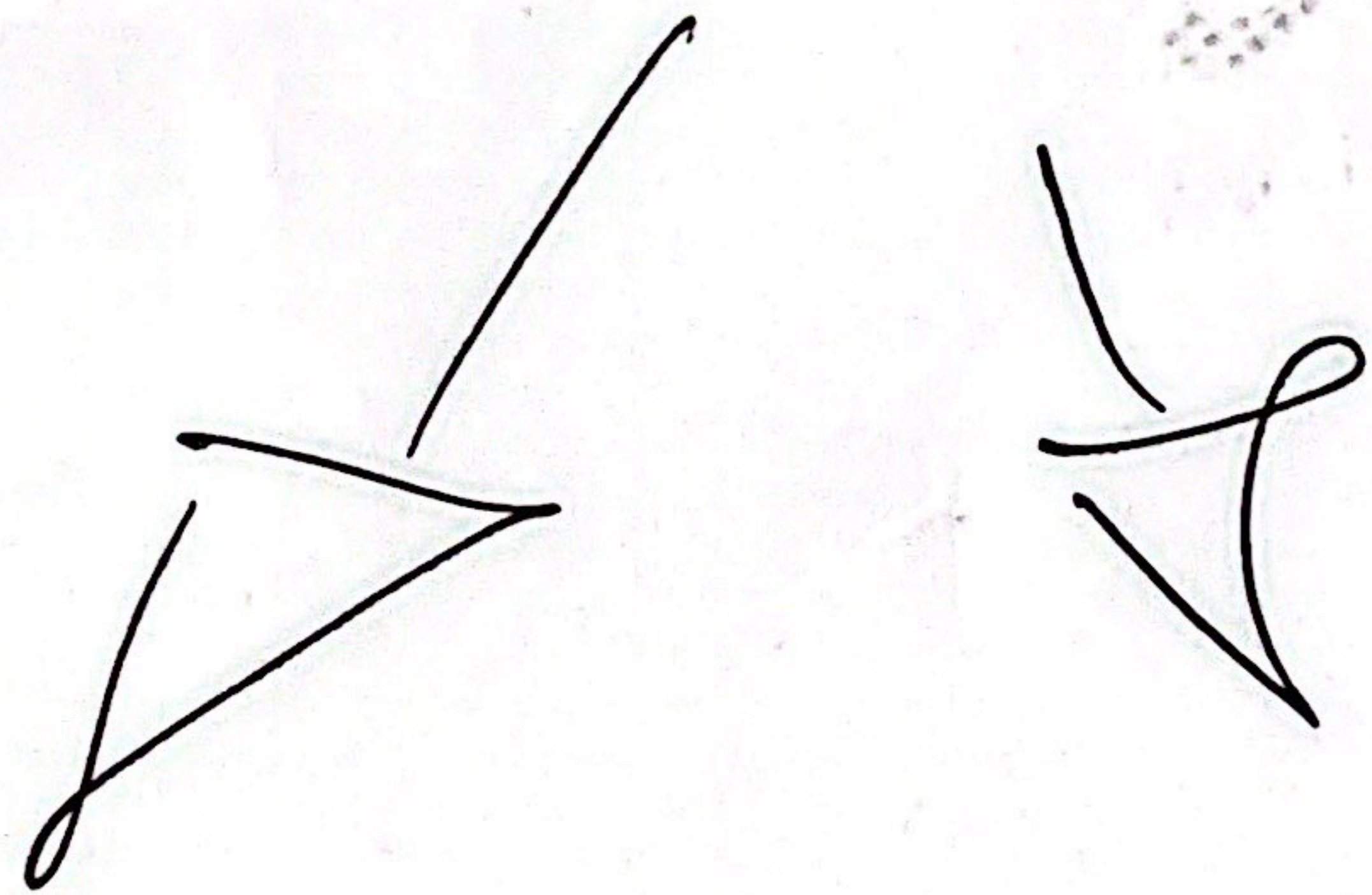
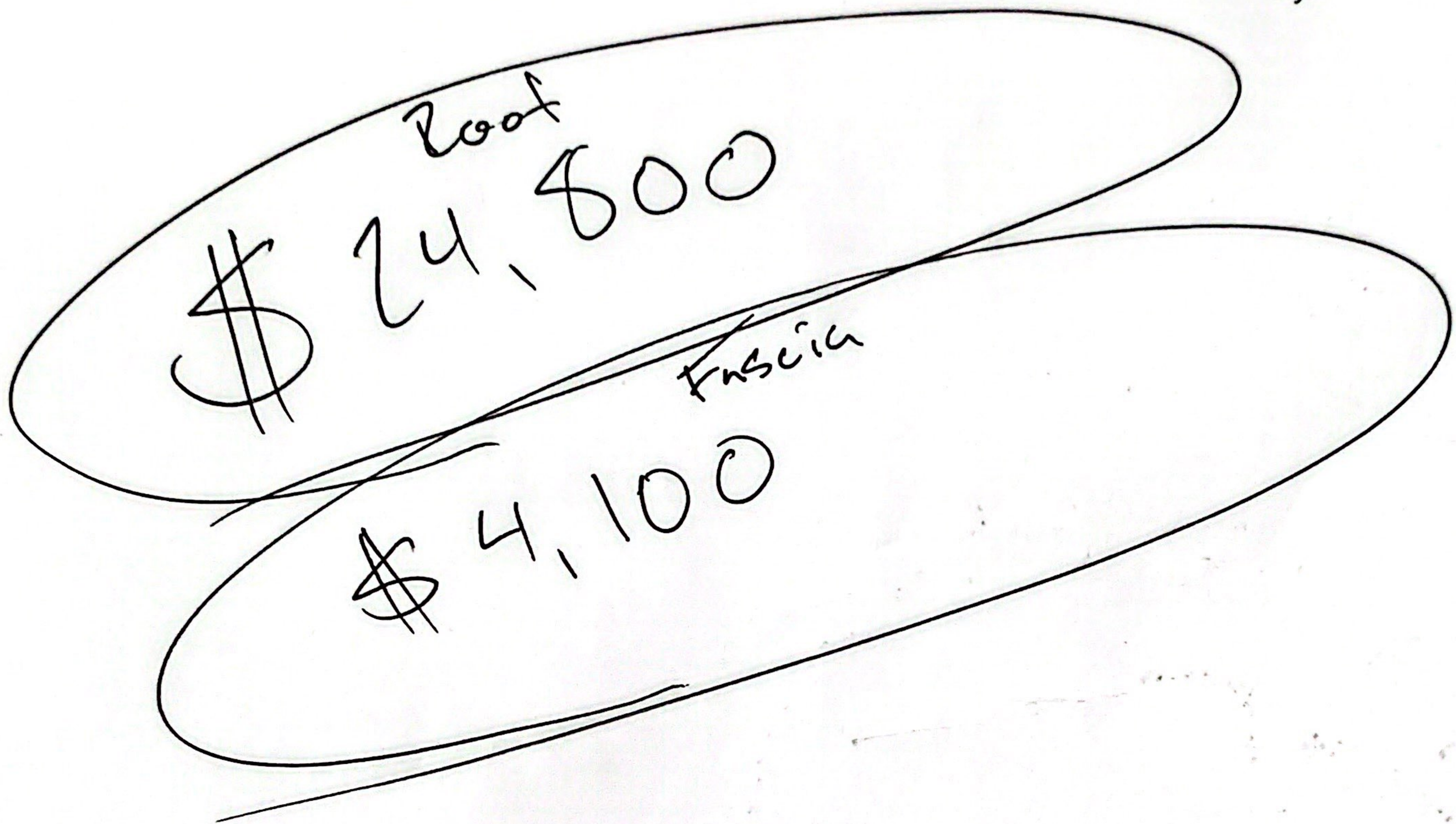
