This property has been a vacant building since March 3, 2012. A code compliance inspection was completed on March 4, 2016 and the property was sold to Jonathan Gutierrez Rivera, who went through the sale review process on March 9, 2016. Since that time, one building permit was pulled on April 8, 2016. It is DSI staffs' belief that Mr. Gutierrez Rivera has done work on the building without permits. Since he has not fulfilled his obligations set forth in the sale review process, it is being scheduled for public hearings to hopefully get Mr. Gutierrez Rivera to come up with a plan of action to complete the rehab and close out the vacant building file.
