Synopsis :

On 09/06/2022 at approximately 1636 hours, officers responded to 2193 Nortonia Avenue for suspicious activity. The caller reported hearing windows breaking and seeing a male in the backyard of the address. Officers were unable to make contact with the homeowner and unable to clear the house due to the massive quantities of items piled inside the house.

Narrative :

On 09/06/2022 at approximately 1636 hours, I Officer S. Higgins and Officer N. Kinn (SQD-365), responded to 2193 Nortonia Avenue for suspicious activity. The complainant, [REDACTED] (Nortonia Avenue), stated that she believed someone had broken into her neighbors house this morning.

[REDACTED] stated that at approximately 0930 hours she heard the sounds of windows breaking. [REDACTED] looked outside and saw a 2007 Gray TOYT 4RUNNER LIC/GFE353 SPORT UTILITY VEHICLE parked in the driveway to the south side of the address. [REDACTED] stated that she saw a black male in the backyard of 2193 Nortonia Avenue.

[REDACTED] described the male as average height, approximately 30 years of age, skinny build, wearing a black baseball hat, a blue surgical mask, blue latex gloves and black sunglasses. The male was wearing a black t-shirt and black shirts and had tattoos on his arms.

[REDACTED] said that the male saw her looking at her and got back into the passenger side of the vehicle. [REDACTED] was unable to see the driver of the vehicle but saw the drivers hand and stated it was either a tan white male or light skinned black male. The vehicle then pulled out of the driveway and left.

██████████ said at approximately 1515 hours she looked outside and saw a black KIA SUV with no plates pulling out of the driveway but was unable to see any occupants of the vehicle.

We went to the backyard and observed that two windows had been broken. On the ground beneath the windows was a black and yellow construction glove and a small pendant amidst the glass. Officer Kinn took photos of the items and then collected them.

Officers had previously been out to this address for a welfare check on 09/02/2022, the elderly owner of the house, Maureen Judith Watson (DOB/1944-01-26) had not been seen. Officers checked the house and found the house almost impossible to navigate, they were unable to locate WATSON. The house was boarded up. (CN: 22-162-355)

We called for a board up crew to open the house for us to attempt to clear. Once the house was open we realized it would be impossible for us to move past the threshold of the doorway due to the massive amounts of items in the house. The board up crew re-secured the front door and boarded up the two broken windows. A bad odor was coming from the address, but we did not recognize it as a decaying body. Due to the extremely large quantity of trash visible inside the house we believed the smell was caused by the trash and assorted rodents associated with it.

The board up technician said he was the one who had responded on 09/02/2022 to secure the address. He said the address was in the same condition on the original call date as it was today with the excepting of the broken windows. He said the odor was the same as when he had initially boarded up the address. Since the initial board up, the weather conditions have been in the high 70's and 80's with no air conditioning inside the house.

The glove and pendant were later turned into property.

The photos were uploaded to the media vault.
