**Synopsis :**

On 7/12/2022 at 2047 hours, Officers were dispatched to 1410 Carling Drive #101 on a report of domestic (MacLaren Hill). Upon arrival, Officers heard a female crying through the door. For the female safety and welfare, Officers forced their way into the apartment with negative results of victims or suspects. Unknown victim or suspect at the moment.

**Narrative :**

On 7/12/2022 at 2047 hours, I, Officer Saema ( SQD 123) was dispatched to 1410 Carling Drive #101 (MacLaren Hill) on a report of domestic. Before arriving, CAD comments stated that Complainant heard a possible physical domestic. There was a lot of screaming and yelling. The complainant also saw someone being pushed against a window.

Upon arrival, I with assisting Officers made contact with the complainant identified as [REDACTED] (DOB/1985-07-24, c/p (651)353-8605, 1410 Carling Drive #208 ) at the front of the apartment building. [REDACTED] stated that she heard a female crying throughout the hallway and toward upstairs to the second floor. [REDACTED] stated that 10 minutes before calling 911, her

roommate (anonymous c/p 612-607-3724) saw someone being slammed on a window at the back of apartment #101.

Assisting Officers and I went down to the first floor of the apartment building. We observed two cellphones and a black (Yeezy foam runner) shoe outside of the front door to apartment #101. Before we knocked on the door of the apartment, we heard a female individual crying. We then knocked on the door and the apartment went silent until a male individual can be heard stating "who is it." We told the male individual that we were the police and the apartment went silent again. We continued to make our announcements until we heard what appeared to be a door at the rear open and closed. Assisting Officers and I attempted to locate the individuals with negative results.

We went to the rear of the apartment and observed a patio and slide window frames into the apartment. The window frames were closed, and the living room's light and most of the lights were turned off. From outside looking inward toward the living room and bedroom we could not see much as curtains were blocking our views. To the North of the patio, we observed a door that can be entered into the garage of the apartment building. We went to the garage and observed a broken garage door hanger (Unknown if the damage was related to the incident).

We could not determine if there was still a victim or suspect inside the apartment.

We notified SGT McManus (SQD 106) with the information we got.

We continued to make our announcement at the front door of the apartment for any individual inside to come out and talk to us.

After multiple attempts with negative results to make contact with anyone. For the safety of any victims and the female individual welfare or any suspects, SGT McManus arrived on the scene and Officer RICHARDS (SQD 177) used force on the door to make entry. We entered the apartment and searched for any victims or suspects with negative results. We observed trash bags ripped open and trash was all over the kitchen area. We observed miscellaneous items scattered through the apartment.

We observed a mailing envelope with the name of RICHARDSON, SIMONE E (via DVS showed RICHARDSON, SIMONE EMIL, dob: 05/24/1997, 325 S Spruce St Apt 406 Waconia, MN 55387).

Officer BRATSCH (SQD 168) took pictures of the apartment. See supplement report.

Officer RICHARDS (SQD 177) collected the cell phones and shoe. See supplement report.

We attempted to locate any video surveillance in the hallway and garage with negative results.

I knocked on apartment #102 with negative results. I talked to apartment #103 (next to apartment #101) and the owner of the house stated that they didn't hear anything as they had their TV on.

I went back and talked to [REDACTED] stated that they did not get a good look at the victims or suspects when they were fighting inside the apartment, but they only saw someone being slammed onto the rear window. [REDACTED] stated she heard the yelling, screaming, and yelling

from her apartment #208. [REDACTED] stated that this happened more than once and police were not called.

Restpro (c/p 65-379-1999) arrived on the scene and boarded up the front door with metal clips.

**Narrative :**

On 07-12-2022, I (Sgt. McManus), responded to 1410 Carling Drive #107 on a domestic assault.

West officers were sent to the address after a citizen witnessed the female from the unit being assaulted by a male.

Upon arrival I was advised by officers on scene that upon their arrival and after speaking to the witness they went to the apartment where they discovered 2 cell phones and 1 shoe outside the apartment door. Both phone were actively ringing while officers were on scene.

Officers advised that they could hear a female crying inside the apartment and they knocked on the door to investigate the domestic and check the welfare of the female.

Once officers knocked a male came to the door and without opening the door asked who was there. The officers identified themselves at which time the male inside refused further communication and officers could no longer hear the female inside.

Upon arrival I confirmed the information again with officers and I had Officer Mursal make numerous announcements with negative results.

I ordered Officer R. Richards to force open the door to check on the safety and welfare of the female that had been assaulted according to the witness and the additional information obtained by officers.

Officers cleared the apartment with was unoccupied upon entry. There were numerous indications that a struggle-fight-domestic had occurred.

Officers photographed the damage to the door and collected the cell phones that were left in the hallway.

I advised the officers to attempt to identify the victim and suspect with neighbors assistance and also note if any video cameras where present that may have captured the incident.

Officers called DATA and ordered a board up crew.

**Narrative :**

On 07/12/2022 at 2050 hours I, Squad 168, M. Bratsch responded to 1410 Carling Drive in response to a report of a domestic.

I arrived on scene and spoke with the complainant, [REDACTED] who stated that she heard shouting and witnessed someone getting shoved against a window. [REDACTED] stated that they believed it was in apt 101. We went down stairs to apt. 101, I observed two cell phones and a shoe laying on the ground in the hallway outside the apartment door. One of the phones was ringing. We went to the door and I heard a female crying. We knocked on the door and a male voice ask "who is it?" We announced ourselves as Saint Paul Police. I then heard what sounded like a door opening from elsewhere in the apartment. I then went to the back door and looked out side. I did not see anything. We went back to apt. 101 and knocked again, but did not receive any answer.

I went to the back to watch the rear exit of the apartment. Squad 106, Sgt. Mcmanus arrived on scene and assisting officers forced entry into the apartment to check the safety and welfare of the female that was inside. I was then let inside by assisting officers and assisted in clearing the apartment. We did not find anyone inside, but the apartment appeared in disarray. I took pictures of the scene, the damaged door, and the cell phones. The cell phones continued to ring while we were on scene, and an additional cell phone was ringing inside the apartment, displaying the same phone number as the phone outside.

I later went through the garage to look for security cameras and found one of the garage doors to the parking garage was damaged. I took pictures of the garage door. While in the garage, Officer R. Richards aird that he saw a black male standing at the back door of apartment 101. We went to the back door of the apartment but did not find anyone. A resident who witnessed the black male stated she saw two black males run from the area of the apartment into a white jeep with not license plates drive away in an unknown direction.

**Narrative :**

On 07/12/2022 at approximately 20:57 hours, I SQD 177 (R.Richards) responded to 1410 Carling Drive #107 in which would later changed to APT 101, Saint Paul, MN 55108 for a Domestic. While en route C.A.D comments said that the caller could hear a physical Domestic and lots of screaming and yelling and someone being pushed against a window.

Upon arrival, with SQD 123 (A.SAE MA) and SQD 168 (M. Bratsch), we responded to 1410 Carling Drive APT 101 for a report of screaming and a women who was said to be pushed on balcony. While making our way to apartment 101, I came across several items that were discovered on the floor in front of APT 101. The items that were discovered on the floor were two cell phones and one pair of shoes. After discovering the three items in front of the door, I then proceeded to make my way to APT 101, where I decided to listen for anyone inside. While listening, I could hear what I believed to be a female voice that was crying in the background of APT 101 for several seconds. After hearing the female crying in the back ground, I then proceeded to knock on the door where I announced our presence to whoever was inside. After announcing our police presence, the sound of a female crying inside suddenly stopped and seconds later a male voice was heard on the other side of the door who verbalized "who is it". I then notified to the male on the other side that it was the police. After announcing that it was the police at the door, I along with other Officers could here a door be opened from inside of the apartment and the sound of someone running out through a door connected to apartment 101.

After notifying SGT (J. MCMANUS) SQD 106 of the incident, I then forced entry into the apartment by kicking the door open after numerous knocks on the door, due to me believing that someone maybe in danger. After booting the door down, I along with Officers on scene began searching apartment 101 for anyone inside of the apartment and later discovered that the apartment was empty. After clearing the apartment, photos were taken of the scene and I assisted with collecting the several items which included the two cells phones and the shoe that were discovered outside of apartment 101. While inside the apartment, I located a third cell phone that was a dark blue flip phone that was located on the floor in front of the bathroom door.

While on scene, it should be noted that the dark blue flip phone inside of the apartment and also one of the touch screen cells phones that were sitting outside of apartment 101, began to ring consistently while Officers were on scene. The three cells phones along with the black YEEZY FOAM RUNNER shoes were turned into property as evidence. The phones were placed on airplane mode.
