Hey Mai,

Thanks for connecting.

**Waste Management Ticket number: # 742241 which was made by the homeowner on January 6th.**

I appreciate that Andrew recalls talking to myself. I called Andrew the day I received the abatement letter and got a return phone call the next Monday.

Per our conversation, Andrew and I discussed the mattress and that we had made a special bulk pick up scheduled as early as Jan 6th. I acknowledged that the mattress was in our ally next to the trash bins (per the instructions of Waste Management). Andrew said that he knew trash collection had been running behind and gave us an extension but without mentioning any specific deadline. We did not hear back from him on a new deadline and the date mentioned by him is new information to me.

During that time, the homeowner also tried contacting WM for follow up.

When the mattress was gone we assumed it was picked up by Waste Management and took no further action.

It should also be mentioned that this whole process was done through the understanding that St. Paul residents can claim 3 bulk item pick ups per year; we attempted to access that same process.
