Mr. Sundberg,

In lieu of a formal follow up letter, I wanted to confirm our phone conversation now so you had this in writing now.

Tomorrow at the Public Hearing, Ms. Moermond will recommend the City Council continue the matter for one week, to March 16th.

In the meantime please submit something in writing to me that lays out your request(s), the additional time requested if tenant is required to vacate; a proposed agreement with the tenant(s) for access to kitchen facilities (what does that specifically mean and how will it work), and last please explain in your own words your second option of installing a kitchen in the basement that unit 3 would have access to (and what that access would look like).

Once your documents are submitted I will send to staff review and call or email you with an update as soon as I can.

I believe I covered all the items in our discussion. The new Public Hearing will be Wednesday, March 16, 2022 at 3:30 pm. in room 300 City Hall. If you are contesting Ms. Moermond's recommendation, you may appear in person or send written testimony to be added to the record to legislativehearings@ci.stpaul.mn.us or by voicemail at 651-266-6805. **Should you wish to address Council directly but not appear in person, you must register in person by noon on the Tuesday immediately prior to your Public Hearing here: <https://www.stpaul.gov/department/city-council/city-council-public-hearing-live-testimony>.** If you don't wish to contest, no further action is needed.

Please note that if you think you will at all wish to testify remotely directly to Council next Wednesday, I encourage you to register, as it does not commit you to speaking should you change your mind on wanting to do so later.
