Moermond: Council originally granted 6 months to rehabilitate property back in May of 2021. You gave an additional 6 months later on, as the project was making progress. It is still not complete. It has been at the 95% mark all summer long. I do not intend to ask the city council to order the building removed when it's at 95%, however there should be financial implications for failing to meet council's deadlines. I intend to recommend next week that half of the \$5000 performance deposit be forfeited if they have not received their certificate of code compliance. They have told me throughout the summer that they would be done in two weeks, and hopefully this inspires completion by Tuesday. If they are not done at the following meeting, I will ask that the balance of the performance deposit be forfeited for failure to meet the expectations

that were outlined. They have been informed in writing of that recommendation as well.
