**NOTICE OF CONDEMNATION  
UNFIT FOR HUMAN HABITATION  
ORDER TO VACATE**

Dear Property Representative:

Your building was inspected on February 11, 2022.

The building was found to be unsafe, unfit for human habitation, a public nuisance, a hazard to the public welfare or otherwise dangerous to human life. A Condemnation Placard has been posted on the building.

The following deficiency list must be completed or the building vacated by the re-inspection date.

**A reinspection will be made on or after March 11, 2022.**

**CONDEMNATION OF THE BUILDING REVOKES THE CERTIFICATE OF OCCUPANCY.**

Failure to complete the corrections may result in a criminal citation. The Saint Paul Legislative Code requires that no building be occupied without a Fire Certificate of Occupancy.

**DEFICIENCY LIST**

1. Exterior - MSFC 603.7 - Immediately discontinue use of unsafe heating appliance until repaired or replaced by a licensed contractor. This work may require a permit(s). Call DSI at (651) 266-8989. Red tags may not be removed except by fire department inspector. *Have a contractor provide an approved meter, have the licensed contractor test all heating equipment and provide a fuel appliance safety report.*

2. Exterior/ interior - SPLC 34.23, MSFC 111.1 - This occupancy is condemned as unfit for human habitation. This occupancy must not be used until re-inspected and approved by this office. ***The building and gas meter were struck by a car. Xcel Energy had to remove the meter. Apply for an emergency permit to repair the exterior wall. Repair the wall in an approved manner and provide a structural analysis on measures to repair the work.***
3. SPLC 39.02(c) - Complete and sign the smoke alarm affidavit and return it to this office.

You have the right to appeal these orders to the Legislative Hearing Officer.
