Good morning,

Thanks for the email, I have attached updated reports here and left notes and some pictures in the file. The report titled "CofO" is most complete and includes pre-existing orders along with new orders related to the vehicle damage. A full interior inspection was unable to be completed due to the situation.

I was scheduled to be out to the building on 5/26 per the discussion at the appeal. The owner had then contacted me to reschedule to 5/27 at 2pm. When I got to the building for the scheduled inspection I found that it was already an active scene with fire and police on site. A vehicle drove through the front wall of the building causing damage to exterior and interior walls. By some coincidence, the accident happened almost immediately before the time I was already scheduled to meet with the owner. The owner arrived shortly afterward and was given an update on the situation. The building has been boarded. It appears structurally sound but will now require new repairs before re-occupancy and the owner was in agreement about this.
