Event: MNUFC v Colorado Rapids and MNUFC v Chicago Fire Games

Description of Variance:

Location: 400 Snelling Ave. N. – Amplified sound within the Street and the Beer Garden Area outside of Allianz Field

Noise Source: Zacharia Litzelswope, MNUFC Director, Events and Guest Experience, has requested two sound level variances, for 95 dBA at no specified distance to present amplified sound with use of a sound system for the MNUFC v Colorado Rapids game and for the MNUFC v Chicago Fire game at 400 Snelling Ave. N- Amplified sound within the Street and the Beer Garden Area – outside of Allianz Field. The variances are requested for the hours of 4:30 p.m. to 7:00 p.m. with a pre-event sound check at 3:30 p.m. for the MNUFC v Colorado Rapids game on Saturday April 16, 2022 and for the hours of 1:30 p.m. until 4:00 p.m., with a pre-event sound check at 12:30 p.m. on Saturday, April 23, 2022 for the MNUFC v Chicago Fire game. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variances shall be for the hours of 4:30 p.m. to 7:00 p.m. with a pre-event sound check at 3:30 p.m. on Saturday, April 16, 2022 for the MNUFC v Colorado Rapids game and for the hours of 1:30 p.m. until 4:00 p.m. with a pre-event sound check at 12:30 p.m. for the MNUFC v Chicago Fire game on Saturday, April 23, 2022. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources on April 16 and April 23, 2022. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 7:00 p.m. on April 16, 2022 and no later than 4:00 p.m. on April 23, 2022.

Applicant has acknowledged that any social gathering associated with this variance must be managed in full compliance with all applicable Governor Walz and Mayor Carter COVID-19 Orders including but not limited to Orders relating to distancing, mask wearing and attendance limits.

Submit comments for Public Hearing electronically. The public may comment on public hearing items in person, in writing or via voicemail. Any comments and materials submitted by 12:00 pm of the day before the meeting, Tuesday, April 5, 2022, will be attached to the public record and available for review by the City Council. Live testimony will be taken in person in the Council Chambers, and by telephone by registering to speak by noon on the day before the meeting.
