NOTICE OF VIOLATION AND REQUEST FOR IMPOSITION OF \$500 MATRIX PENALTY

Dear Licensee:

The Department of Safety and Inspections ("Department") has recommended adverse action against the Auto Repair Garage License held by Castillo Auto Repair ("Licensee") herein for the premises located at 744 3rd Street ("Licensed Premises") based on violations of your license conditions.

Saint Paul Legislative Code Section 310.06 sets forth a variety of reasons under which adverse actions be based. Section 310.06(b)(5) says that adverse action can be pursued for failure to comply with a condition set forth in the license. In your case, the license conditions that the Department bases its request for adverse action on are license conditions #2, #5 and #7.

Synopsis of alleged facts:

On January 21, 2022, Inspector Muhammad from the Department went to the Licensed Premises to conduct a follow-up inspection. Inspector Muhammad spoke with owner Issac Castillo to review the correction notice that was sent via email on January 7, 2022. In that notice, Inspector Muhammad stated that, during a December 1, 2021 inspection of the Licensed Premises, he observed multiple violations of your license conditions and gave you a timeline to come into compliance with these conditions. The notice also stated that a follow-up inspection would occur on or before January 17, 2022.

During the follow-up inspection, Inspector Muhammad observed and documented with photos violations of license conditions #2, #5, and #7.

Violation #1 - Failure to follow approved site plan in violation of Condition #2:

License condition #2 of the License for the Licensed Premises states that:

"Customer and employee parking, on the licensed premises, shall be in accordance with the approved site plan on file with the Department of Safety and Inspections (DSI). A maximum of six (6) vehicles may be parked on the exterior of the premises at any time."

Violation #1 Facts: On January 21, 2022, during the follow-up inspection, Inspector Muhammad discovered a truck and white car parked on the Licensed Premises in an area not approved on the site plan on file with DSI.

The Department asserts that these facts along with attachments herein constitute proof of a violation of License Condition #2 by a preponderance of the evidence for failure to follow original site plan.

Violation #2 – Employee vehicle parked on public street in violation of Condition #5:

License condition #5 of the License for the Licensed Premises states that:

"Customer and employee vehicles shall not be parked or stored on the street or alley. This includes cars which have been repaired and are awaiting pick-up by their owners."

Violation #2 Facts: On January 21, 2022, during the follow-up inspection, it was discovered that an employee vehicle was parked on a public street.

Violation #3 – Failure to maintain parking lot violation of Condition #7:

License condition #7 of the License for the Licensed Premises states that:

Violation #3 Facts: On January 21, 2022, Inspector Muhammad observed a Ford Flex (MN Lic # 373WJJ) and a white truck parked on the license premises for more than 10 days.

Under Saint Paul Legislative Code Section 310.05, these violations of your license conditions are first time violations. The penalty matrix laid out in 310.05 prescribes a \$500 fine for a First-time Violation.

You have four (4) options to proceed:

- If you do not contest the imposition of the proposed adverse action, you may do nothing. If I
 have not heard from you by February 16, 2022, I will presume that you have chosen not to
 contest the proposed adverse action and the matter will be placed on the City Council
 Consent agenda for approval of the proposed remedy.
- You can pay the \$500 matrix penalty. If this is your choice, you should make payment directly to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than **February 16, 2022**. A self-addressed envelope is enclosed for your convenience. Payment of the \$500.00 matrix penalty will be considered a waiver of the hearing to which you are entitled.
- 3. If you wish to admit the facts but you contest the \$500 matrix penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting to the facts and requesting a public hearing no later than **February 16, 2022.** The matter will then be scheduled before the City Council to determine whether to impose the \$500 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 4. If you dispute the facts outlined above, you may request a hearing before an Administrative Law Judge (ALJ). You will need to send me a letter disputing the facts and requesting an administrative hearing no later than **February 16, 2022.** At that hearing both you and the

City will appear and present witnesses, evidence and cross-examine each other's witnesses. After receipt of the ALJ's report (usually within 30 days), a public hearing will need to be scheduled. At that time, the City Council will decide whether to adopt, modify or reject the ALJ's report and recommendation.

<u>Please note:</u> If you choose an administrative hearing, the Department of Safety and Inspections reserves the right to request that City Council impose the costs of the administrative hearing per Saint Paul Legislative Code § 310.05 (k).

If you have not contacted me by February 16, 2022, I will assume that you do not contest the imposition of the \$500 matrix penalty. In that case, the matter will be placed on the City Council Consent Agenda for approval of the recommended penalty.

12. No repair of vehicles may occur on the exterior of the lot or in the public right-of-way (e.g., street, alley, sidewalk, boulevard, etc.). All repair work must occur within an enclosed building.

13. The display of tires outdoors for-sale shall be limited to the area shown on the approved site plan on file with DSI. Outdoor display of tires for-sale shall only be done when the business is open to the public, and all tires shall be stored inside the building when the business is closed. No tires (for-sale and/or discarded) may be placed in the public right-of-way (e.g., street, alley, sidewalk, boulevard, etc.).

14. The Second Hand Dealer - Motor Vehicle parts license is restricted to the sale of used tires only.
