Here is the response that I received from the hauler. It appears that there were two bulky item tickets that requested pick up on 1/26/2022 and 1/28/2022. However a note on the account from 1/27/2022 stated that there were no bulky items left out on 1/26/2022. Therefore the property owner was never charged for the bulky item pick up. It does appear that another pick up was scheduled for 1/28/2022 but nothing appears to have been picked up.
