Synopsis :

On 11/12/2021 at 0342 hours, OFC was sent to 799 Como Avenue on criminal damage to property. Complainant stated unknown suspect(s) broke glass door to the address. Complainant said no entry was made and suspects left the area in a possible older style silver Oldsmobile.

Narrative :

On 11/12/2021 at 0342 hours, SQD 113 (D. McDonald) was sent to 799 Raymond Avenue North (Shag Studio) on criminal damage to property.

Upon arrival, I identified business owner by MN DL as Goodale, Chelsea NMN (DOB/1977-10-20).

Goodale was inside of her business, when she heard a crashing sound. She said she went to investigate it and observed the north side door to the business was damaged.

Goodale said she did not observe any suspect(s), but she did step out of the business and saw an older style Oldsmobile (possibly) unknown make/ model, was seen west bound on Territorial Road, from her location. Goodale said she saw two individuals inside of the motor vehicle.

Goodale did not have an estimate for the replacement cost of the door.

I contacted Saint Paul board to secure the address.

I did not observe any cameras in the area, which might have captured the event.
