Openings for a water utility tech I working in damage prevention and a GIS specialist II are promotional only and close at 4:30 p.m. on Monday, Dec. 13.

All but the GIS specialist II must possess and maintain a valid Minnesota class D Driver's license or equivalent out-of-state driver's license.

## Water Lab Tech. I

Performs entry-level technical work in the water quaility laboratory by collecting, labeling, documenting, and preserving samples from the distribution system, wells, lakes, streams, and various water sources. Assists with the calibration, repair, and maintenance of laboratory equipment. Monitors and records incubator and refrigerator temperatures. Collects standard water samples at new or replaced mains.

#### Water Distribution Field Supervisor

Performs highly responsible administrative and supervisory work in the distribution division, overseeing personnel assigned to construct or maintain water mains, hydrants, valves, and water services for effective and efficient water services.

Inspects and enforces divisional excavation safety program and policy.

Manages up to twelve field crews performing water main construction, repair, and preventative maintenance tasks.

Standard working hours are Monday – Friday from 7 a.m. to 3:30 p.m., with additional overtime hours necessary to manage construction projects and emergency response for water main breaks.

#### Water Utility Tech. I

This posting is open to current city of Saint Paul employees who meet the Civil Service promotion rule, which includes two years of certified service.

The position is with the Damage Prevention Unit. Typical duties of the position include:

- Locating and marking watermain facilities
- Using GIS mapping and software
- Using Microsoft Office for team communication and meetings
- Coordinating multiple inspection projects, preparing as-built drawings, and working with project engineers to review and analyze projects during design phase

This position is responsible for working extended hours outdoors, mostly during the spring through autumn. Winter outside work may be required on occasion. Typical hours are weekdays 7 a.m. -3:30 p.m. with overtime required on a project-by-project basis. Weekend and holiday work may be occasionally requested.

## **GIS Specialist II**

This posting is open to current city of Saint Paul employees who meet the Civil Service promotion rule, which includes two years of certified service.

Performs intermediate level work providing compilation, maintenance, operation and assists with the assessment of a department Geographic Information System (GIS) and related programs.

Maintains spatial and attribute data, facilitates data capture, and provides map design, production, and spatial data modeling.

Builds GIS applications, provides technical assistance to users, and assists less experienced staff.

Uses applications such as ArcGIS Desktop, database management, office productivity, and related software.
