Re: Remove or Repair of the Structure at 1501 Clarence Street

Dear Doug Grimm:

This is to confirm that at the City Council Public Hearing on November 9, 2022 Legislative Hearing Officer Marcia Moermond will ask they refer the matter back to Legislative Hearing Tuesday, **December 13, 2022 at 9:00 am** in room 330 City Hall/Courthouse <u>if \$5,000</u> <u>Performance Deposit is posted by close of business November 4, 2022.</u>

For your reference, the following items must be completed before receiving a grant of time from the City Council to rehabilitate the property:

- **1.** Past due real estate taxes must be brought current (currently taxes for the first half of 2022 are delinquent in the amount of \$4,119.35; second-half taxes are due October 15);
- 2. submit evidence of financing sufficient to complete the rehabilitation. Staff estimates costs to exceed \$100,000. If total for bids are more than 20% less than staff estimate, a high level of detail will be required. Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case by case basis;
- 3. apply for a Code Compliance inspection with the Department of Safety & Inspections Your code compliance application must include lock box code and box must be attached to door for use;
- 4. submit an affidavit indicating the finances will be dedicated to completing the **project** and not diverted until a code compliance certificate is issued; and
- 5. submit work plan, sworn construction statement, or scope of work. This should include signed subcontractor bids and a <u>schedule</u> for completion of the project; and
- 6. the property must be maintained.
