Re: Remove or Repair of the Structure(s) at 575 & 595 Park Street

Dear Mr. Viggiano:

This is to confirm that at the City Council Public Hearing on August 9, 2022, at which you did not appear, Legislative Hearing Officer Marcia Moermond will recommend the following:

- 1. <u>575 Park:</u> Property must have received its Code Compliance certificate, the nuisance is abated and matter resolved by September 9, 2022.
- 2. <u>595 Park:</u> In order to receive an additional grant of time by Council these items must be completed by close of business September 2, 2022 you must:
 - a. **Post an additional \$5,000 Performance Deposit** (your original \$5,000 will be continued) (*this was done 8/10 and satisfied*);
 - b. provide updated work plan and schedule;
 - c. updated proof of financing sufficient for completing the project (this was approved 8/11/22 and is satisfied);
 - d. update affidavit dedicating funds to the project.

As always the properties need to continue to be maintained. Those documents can be emailed to me at <u>Joanna.zimny@ci.stpaul.mn.us</u> or dropped off to our office at the address above Monday through Friday between 8:00 am and 4:00 p.m.

When 575 Park is completed you can request your Performance Deposit back in writing to Robert Humphrey at robert.humphrey@ci.stpaul.mn.us.

These matters will again to before the City Council on for **Wednesday**, **September 7**, **2022** at **3:30 pm**. in room 300 City Hall. If you will be contesting Ms. Moermond's recommendation from the August 9 hearing, or you did not complete the items above, you may appear in person or send written testimony to be added to the record to legislativehearings@ci.stpaul.mn.us or by voicemail at 651-266-6805. Should you wish to address Council directly but not appear in person, you must register in person by noon on Tuesday, September 6, 2022 here:
