RE: Statement for Public Hearing on Reparations in St. Paul City Council Meeting on Dec. 21

Dear St. Paul City Council,

Students in my classes have been involved in project-based learning experiences regarding homelessness, poverty, interpersonal violence, and other issues in the Frogtown/Summit/University Neighborhoods over the past several years. During this time, some disturbing information has come to light.

The racial wealth gap in the city of St. Paul is pervasive, persistent over time, and is closely related to a history of systematic oppression and inequality. According to the US Census Bureau, for example, the St. Paul per capita income for 2013-2017 is an average of \$15, 577 for African Americans in comparison to \$42, 874 for whites. Likewise, St. Paul home ownership for 2013-2017 is 16.9% for African American (one race) in comparison to 61.2% for whites.

The racial inequalities which exist in St. Paul are unacceptable. Something needs to be done about these disturbing situations. The ordinance from the Saint Paul Recovery Act Reparations Legislative Advisory Committee is a step in a promising direction.

Jones & McElderry (2021) recently wrote about how responsible entities have a legal obligation to remedy past harms. In addition, there is a moral obligation to address injustices rooted in slavery, lynching, redlining, and other atrocities which the Advisory Committee has documented . Emerging evidence reported by Peters (2/2/22) suggests a third reason to pursue reparations: Effectiveness of the intervention. For example, studies in Vancouver and places ranging from Newark, NJ to Chicago have shown cash payments can address homelessness more effectively than standard procedures.

Although we may have been a leader at one time, St. Paul, Minnesota is not in a leadership position in terms of addressing the racial wealth gap at present. I personally support the ordinance set forth by the Saint Paul Recovery Act Reparations Legislative Advisory Committee as one step forward in the process of addressing one part of racial inequality.
