Team effort restores pump station service, informs the public

Staff steps up to address power outage

Huge shout to staff who responded to the power outage at the Beebe Road pump station on Monday and and the resulting loss of system pressure.

Water sampling test did not show contamination and the boil water advisory was lifted on Tuesday.

Staff from every division within SPRWS stepped up to provide their expertise and dedication to ensureour customers were provided safe and reliable water service.

Around noon on Monday, Aug. 8, the Beebe Roadpump station shut down due to a loss of power from Xcel Energy.

This in turn caused pressure issues in the system in the area.

In an abundance of caution, the decision was made to issue a boil water advisory for residents living in the affected area.

It required that staff work to restore pump station operations after power was restored.

Everyone from the pumping engineers to electricians to SCADA staff to other production crews and distribution staff and to the call center, dispatch, maps and records, engineering, water quality, and the front desk were all actively involved.

Flushing crews were sent out, staff took water

samples, IS sent out emails and customer service sent out messages to customers, as did the safety and security staff to Ramsey County residents.

Administration staff planned and coordinated the response and informed the public.

The work went well and the advisory was lifted within 24 hours of the incident.

It is safe to donate blood, and

effective measures are taken at every step of the process for every-one's safety. Masks are required at the donation site, and strong safety protocols are followed. Please be ready to share which vaccine you have received if asked (please bring your vaccination card if you have one).

Donors from the Black community are especially needed to help sickle cell patients receive the most compatible blood match. Those donors who self-identify as Black will receive a sickle cell trait screening and receive results if desired.

Most donations take about an hour, so please book an appointment (walk-ins are not possible).
