I am attaching the noticed dated August 16, 2022, as well as the warning that was sent to you on September 15, 2022, (you are the 3<sup>rd</sup> and 4<sup>th</sup> recipient down). Both documents lay out the procedures for appealing, and unfortunately we are well past the window for doing so. The September 15 document clearly states that the amount owed will be assessed and adds the possibility of penalties.
