The Department of Safety and Inspections will be recommending the following conditions: 1) Variance will be for the hours of 2:00 p.m. to 11:00 p.m. on Friday, August 11, 8:00 a.m. to 11:00 p.m. on Saturday, August 13, 2023. 2) **Main Stage update**: All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 100 dBA at 75 feet from the sound source. Amplified sound on the Main Stage must end at 10:00 p.m., per Parks Department end time Policy. 3) Pub Stage (Tent): All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 100 dBA at 75 feet from the sound source. Amplified sound on the Main Stage must end at 10:00 p.m., per Parks Department end time Policy. 3) Pub Stage (Tent): All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 92 dBA at 50 feet from the sound source.
