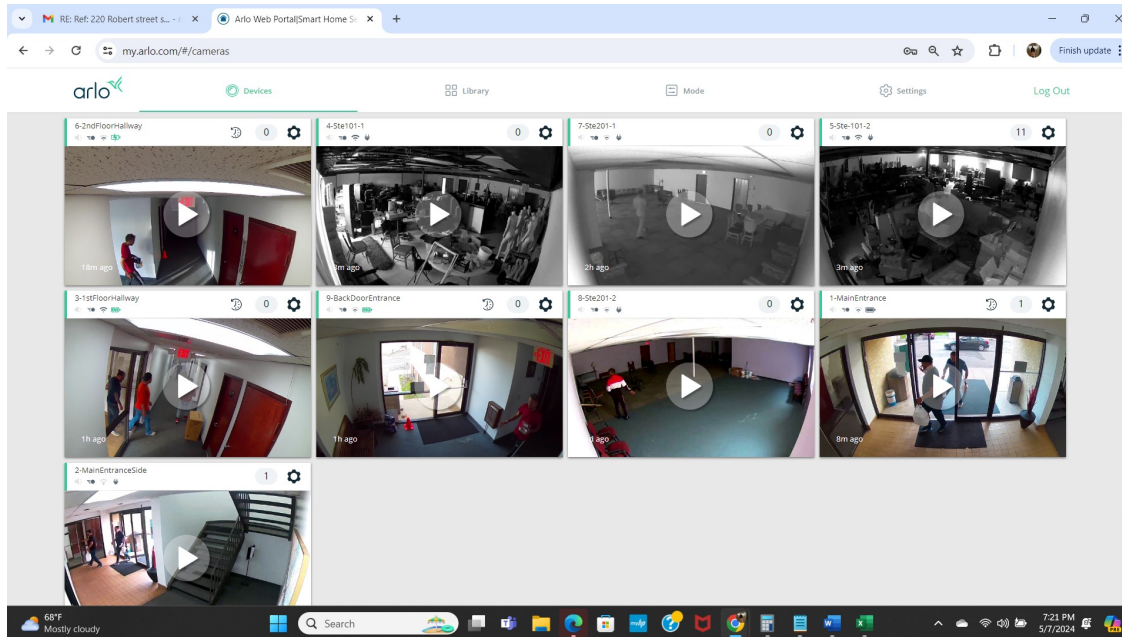

I hope this message finds you well. I wanted to extend my gratitude for your time yesterday morning. Your guidance on our security system was invaluable, and I truly appreciate it. I wanted to provide you with an update on the progress we've made since our discussion:

Following your suggestion, I've implemented several changes:

I relocated two existing cameras to new positions in Suite 101.  
Adjusted the viewing angle for the camera in Suite 201 upstairs.  
Installed two additional cameras - one in the second-floor hallway and another at the front lobby, facing the entrance to capture close-up footage of anyone entering the building.

I'm currently in the process of conducting a thorough 72-hour test to ensure everything is functioning optimally. Here are the areas I'm testing:

Regular Power Supply & Network Connection: Ensuring consistency in both power supply and network connectivity.  
Image Quality Check: Monitoring image quality throughout the day, including different lighting conditions, to ensure there are no distortions or abnormalities.  
Motion Detection: Verifying if motion triggers recording as expected.  
Recording: Ensuring that all footage is saved properly.  
So far, everything appears to be in order, but I want to ensure we've covered all bases. I'll provide you with further

details by Sunday once the testing is complete.
