Synopsis :

Narrative :

On 2/8/2024 at approximately 1500 hours, we SQD-374 (LOR/CHAZONKHUEZE) responded to 724 Jessamine Ave E for a report of a domestic assault. CAD comments stated that the suspect was a juvenile female, identified as, BAKER, Jadayah [REDACTED], 724 Jessamine Ave E, No Ph) was fighting with her mother and broke the front window with a chair. The mother was identified as, MORGAN, Jade Samara (DOB/1989-06-12, 724 Jessamine Ave E, C/P: (952)818-6710).

Upon arrival, we saw BAKER in the front porch, but she walked back inside the home after seeing that we arrived on scene. MORGAN then came outside to talk to us and informed us of the incident.

MORGAN stated that BAKER was being disrespectful and was being aggressive towards the toddler children inside of the home. MORGAN confronted BAKER and according to MORGAN, BAKER began yelling at MORGAN and assaulted her. MORGAN stated BAKER punched her in the face and head approximately five to six times which caused MORGAN to chip her front tooth and sustain a welt on her head. MORGAN stated BAKER also kicked her in the abdomen. MORGAN showed us her white t-shirt which showed a dirty footprint left on her shirt from BAKER kicking her.

MORGAN stated she did not want BAKER to get in trouble but stated BAKER needs to learn that her behavior is not okay.

A juvenile male on scene, which is MORGAN's son, confirmed that BAKER came outside and used one of the chairs on the front porch to break the front window. The window is approximately a 4ft by 4ft window which was shattered. We informed MORGAN we would call for a board up crew upon her request.

We took photographs of MORGAN including the footprint left on her shirt. I, Officer Lor, attempted to speak to MORGAN more and asked for pictures of her teeth but she declined.

BAKER was inside the home, and we wanted to speak to her. We had determined that with MORGAN's statements, we had probable cause to arrest BAKER but wanted to speak to her first. BAKER was inside the home and was refusing to exit the home to speak to us. We walked inside the front door and informed BAKER we wanted to talk to her, but she was trying to go somewhere else inside the home. Because we did not want her running around the home and possibly lock herself in a room, we informed BAKER she was under arrest and grabbed her arms to place her in handcuffs. BAKER immediately began screaming and resisting us from placing her in handcuffs. We tried to speak to BAKER to get her to comply, but she was screaming loudly, therefore, we conducted a two-officer resistive handcuffing and were able to place her into handcuffs. Officer Chazonkhueze escorted her to our squad car (1870) and placed her in the backseat after searching her.

I attempted to speak to MORGAN more, but MORGAN appeared to be stressed out and kept talking about her window and other things. I wanted to read her blueprint questions, but MORGAN was unable to focus. We left shortly after due to BAKER's erratic behavior and wanted to transport her to the JDC quickly.

We transported BAKER to the Ramsey County JDC and booked her for Misdemeanor - Domestic Assault.

We informed Sgt. Zilge (SQD-306) of the arrest and resistive handcuffing.

On 02/08/2024 at approximately 1500 hours, we, squad 374 (Chazonkhueze/Y. Lor) were in full Saint Paul Police uniform and driving in a fully marked Saint Paul Police squad 1870.

We were dispatched to 724 Jessamine Avenue for a female yelling for help and hitting the glass door with a chair attempting to get in. A second complainant called, who was later identified as

MORGAN, JADE ([REDACTED]). MORGAN is the resident at 724 Jessamine Avenue and stated her daughter was out of control, broke her front house window, and assaulted her.

Upon arrival, we observed the suspect, who was later identified as BAKER, JADEYAH ([REDACTED]) standing on the front porch. As we approached the house, I observed BAKER go inside the house. We spoke to MORGAN, who stated her daughter is a runaway and had just came back home. MORGAN stated BAKER punched her multiple times on the face, mouth, and chipped her tooth. She showed me her front tooth and I observed it to be chipped. MORGAN also stated BAKER must've grabbed one of the chairs on the patio and used it to break the front window.

While we were speaking with MORGAN, BAKER made her way to the living room and was walking around the kitchen. BAKER walked towards the front door again and attempted to walk upstairs. We took control of BAKER, advised her she was under arrest, and she immediately tensed up her arms and straightened them out to prevent us from placing her hands behind her back. We were able to place her hands behind her back and place her in handcuffs. Throughout the time we were trying to handcuff her, she continued to scream, and hyperventilate.

I escorted her to our squad and searched her incident to arrest. I did not locate anything of evidentiary value.

I placed her in the back seat of my squad and she made complaints of the handcuffs being too tight. I loosened them up and we transported her to the Ramsey County JDC. While on the way there, BAKER removed her handcuffs and began punching the partition that separates the back seats from the front.

We arrived at the JDC and placed her back into handcuffs.

BAKER was booked for Misdemeanor Domestic Assault.

Sergeant Zilge (Squad 307) was informed of the incident.
