Description of Variances:

Location: 400 Snelling Ave. N. – Amplified sound within the Street and the Beer Garden Area outside of Allianz Field

Noise Source: Zacharia Litzelswope, MN UFC Director, Events and Guest Experience, has requested three sound level variances, for 95 dBA at no specified distance to present amplified sound with use of a sound system for the MNUFC v Portland, MNUFC v Austin FC and MNUFC v LAFC games at 400 Snelling Ave. N- Amplified sound within the Street and the Beer Garden Area – Allianz Field. The variances are requested for the hours of 4:00 p.m. to 7:30 p.m. with a pre-event sound check at 3:00 p.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 4:00 p.m. to 7:30 p.m. with a pre-event sound check at 3:00 p.m. on Saturday, July 1, 2023 for the MNUFC v Portland game, July 8, 2023 for MNUFC v Austin FC game and July 15, 2023 for the MNUFC v LAFC game. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources on July 1, 8, & 15, 2023. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 7:30 p.m. on July 1, 8, & 15, 2023.
