



Comments This is a CONDITIONAL Encroachment Permit issued under the following conditions:

- 1) The owner/licensee will need to obtain a vacation of the applicable right-of-way by 12/31/2024. If a vacation is not obtained by 12/31/2024, the owner/licensee would then either need to discontinue use of the right-of-way and restore it to conditions approved by Public Works OR obtain a new encroachment permit by way of full submittal for review and the applicable review fee payment.
- 2) If a vacation is obtained by or before 12/31/2024, this encroachment permit will terminate at that time.
- 3) In addition to this Conditional Encroachment Permit, the owner/licensee will need to obtain a DSI Zoning Division approval of a parking plan and a completed DSI Licensing Division review.

Licensee acknowledges that use of the public right-of-way fronting the property along Como Ave requires a written-agreement/encroachment-permit be obtained from the City of St Paul Department of Public Works, that such agreement is subject to change/revocation in accordance with applicable ordinances and/or requirements or as stipulated under the agreement, agrees to abide by any terms and/or conditions placed on this agreement, and that they will discontinue use of the right-of-way if such agreement is no longer valid (which would include restoration of the right-of-way space to standards established by the Department of Public Works). Licensee understands that failure to remain in compliance with the agreement would result in adverse action being taken against their license.
