If I need a letter from my Mayo Dr. Please advise by 12:30 so that I may request that if needed. I am a disabled adult under the ADA this provides an opportunity for me to request this accomodation. Please advise if you have a disability compliance officer that I need to co-ordinate this with as this is placing me in harms way to further burden me when the licensed contract has falsely submitted a contract that I did not sign and now after reviewing the contract would not have qualified for. It is incumbent upon this licensed contractor to provide the city with truthful and correct contracts so as to not encumber all of us with having to reprove that in fact I do not qualify for the deferred program. I will be submitting this to the atty general for further supervision and guidance per the atty general's recommendation. Thank you Richard for a prompt response to this most distressing allegation. 

On 7/25/2023 you called me to discuss your private sewer service that was repaired on 6/23/2023. You informed me that because the work was completed much sooner than the sewer contractor had initially indicated, you believe that you had been overcharged by the sewer contractor. With you on the phone, I called the sewer contractor and the city sewer assessment staff person so that we can all discuss the matter. During the phone call, because you indicated that you did not sign the work completion form that had been submitted by the sewer contractor, I asked our city sewer assessment staff person to send you a copy of the form. Because the sewer contractor said that you signed the form, I asked him to review the matter with the employees of his company and let me know what he found out. I called him a few times after our phone call of 7/25/2023 to find out what his response was. I again called him today 7/31/2023 and he still maintained that the form was signed by you. At your request, we are looking at if it is still possible to not certify the sewer assessment. Given that I am an employee of the city rather than the county, I do not know who your county commissioner is. Our goal is to ensure that all residents are treated fairly by the city and all sewer contractors. Please let me know if you have any questions or comments.
