Hello Mr. Hamann,

I want to inform you that on the December 19, 2023, Ms. Moermond recommended that the above matter be continued to June 12, 2024 for no same or similar violations and will reduce from \$516 to \$100. You were to install motion lights, signage, fake camera and cut overgrown vegetation to prevent dumping. As of June 11, 2024, Inspector Martin indicated the conditions were not met, except that there was a motion light, but that may have been there. Therefore, Ms. Moermond is revising her recommendation to reduce from \$516 to \$400. If you wish to contest to this amended recommendation, she will be asking the City Council to continue the public hearing to June 26 at 3:30 p.m. to give you an opportunity to do so.

In order to contest, here are the options:

- 1. appear in person (please arrive before 3:30 p.m. and check in with staff outside Council chambers); or
- 2. Should you wish to address Council directly but not appear in person, you must register by noon on Tuesday, June 25, 2024 to testify via phone via this link: <a href="https://www.stpaul.gov/department/city-council/city-council-public-hearing-live-testimony">https://www.stpaul.gov/department/city-council/city-council-public-hearing-live-testimony</a>.

If you don't wish to contest then no further action is needed, and the Council will proceed with Ms. Moermond's recommendation.
