



As owner or person(s) responsible for 845 HOWELL ST N: please eliminate the nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

1Remove improperly stored or accumulated refuse which may include: garbage, rubbish, loose and scattered litter, discarded furniture, appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from entire property including yard, boulevard, alley, and driveway.

SPLC 105.01. - DUMPING/OBSTRUCTIONS: It is unlawful for any person to throw or deposit, any garbage or other waste material upon any part of any boulevard. It is unlawful for any person to erect or maintain any booth or structure of any kind whatever upon any boulevard, or any other obstruction.

PLEASE REMOVE THE PLANTER BOXES FROM THE BOULEVARD. THANKS Comply before May 30, 2023





No appeals may be filed after that date. You may obtain an appeal application from the City Clerk's Office, Room 310 City Hall, 15 W. Kellogg Blvd., St. Paul, MN 55102. (651) 266-8688. You must submit a copy of this Order with your appeal application.
