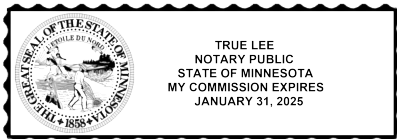

ON A PROPOSAL FOR HOST APPROVAL
OF THE ISSUANCE OF MULTIFAMILY
HOUSING REVENUE BONDS
(CENTRAL TOWERS APARTMENTS PROJECT)

NOTICE IS HEREBY GIVEN that the City Council of the City of Saint Paul, Minnesota (the "City") will meet on Wednesday, December 13, 2023 at 3:30 p.m., or as soon thereafter as the matter may be heard, in the City Council Chambers, City Hall, 15 West Kellogg Boulevard in the City to hold a public hearing related to (i) giving host approval to the proposal of Schuett Central Towers, LLLP, a Minnesota limited liability limited partnership (or another entity to be formed by or affiliated with The Schuett Companies, Inc., the "Borrower") that the City of Mounds View, Minnesota (the "Issuer") issue its conduit housing revenue bonds or other obligations, in one or more series, at one time or from time to time, (the "Bonds") to finance the Project described below pursuant to Minnesota Statutes, Chapter 462C; (ii) approving a joint powers agreement between the Issuer and the City; and (iii) adopting a joint housing program for the Bonds.

The Bonds will be issued to (i) finance the acquisition, renovation, construction and equipping of an existing 193-unit apartment community and related amenities all located at 20 E Exchange Street in Saint Paul, Minnesota (the "Project"); (ii) fund one or more reserve funds to secure the timely payment of the Bonds, if necessary; (iii) pay interest on the Bonds during the construction of the Project, if necessary; and (iv) pay the costs of issuing the Bonds. The Borrower, or an affiliated entity, will own and operate the Project.

The estimated maximum aggregate principal amount of Bonds to be issued by the Issuer to finance the Project will not exceed \$16,500,000.

The Bonds or other obligations, if and when issued, will be special, limited revenue obligations of the Issuer payable solely from the revenues expressly pledged to the payment thereof, and will not constitute a charge, lien or encumbrance upon any property of the City, the Housing and Redevelopment Authority of the City of Saint Paul, Minnesota (the "HRA") or the Issuer. Such Bonds or other obligations will not be a charge against the City's, the HRA's or the Issuer's general credit or taxing powers and will not constitute a general or moral obligation of the City, the HRA or the Issuer, but will be payable from sums to be paid by the Borrower pursuant to a revenue agreement.

A copy of the housing program for the Project will be on file and available in electronic form through an emailed request to Jenny Wolfe at the Department of Planning and Economic Development at jenny.wolfe@ci.stpaul.mn.us on or before the date of the hearing, during normal business hours.
