Dear Council President Brendmoen and Councilmembers,

I recently moved to the Payne-Phalen neighborhood in Ward 5, and have loved walking the trails around Lake Phalen, Round Lake, and Keller Lake. The green space is an invaluable part of our neighborhood. It would be a shame if our city's smoking policy hindered mine and my neighbors' access to these healthy, outdoor community spaces.

I understand the intention behind limiting smoking to youth activity areas, but doing so wouldn't protect kids completely. Kids don't solely use playgrounds or athletic areas at parks; they ride their bikes on the trails, get pushed around in strollers, and have birthday parties under the pavilions, among other things. Per Minn. Stat. § 342.09(b)(9), an individual may not smoke or vape cannabis where the smoke or vapor may be inhaled by a minor. If kids can access the entirety of a park, shouldn't they be protected wherever they play?

Children aren't the only group that deserve protection from secondhand smoke, either. What about my elderly neighbors, my neighbors in recovery, my neighbors who just want to get some fresh air? Someone's choice to smoke shouldn't take away our ability to breathe clean air.

Saint Paul must lead by example. All of the media attention around this ordinance puts the city in a unique position to make the right choice for public health and inspire other communities to do the same. We must avoid the normalization of any kind of substance use by keeping our parks smoke free.

The <u>"About Saint Paul" page</u> of the city's website claims "The sights, sounds, and aromas [of Saint Paul] are the breath of our unique, charming old neighborhoods." Can that be true if we greet our residents and visitors with the aromas (and health effects) of secondhand smoke and undermine one's ability to breathe in places that are meant to be safe, fun, and healthy?

Re: Letter in support of smoke-free St. Paul parks

Dear members of the St. Paul City Council:

I am writing on behalf of Tobacco-Free Alliance to express our support for the proposed ordinance that would prohibit smoking of tobacco, cannabis, and hemp products in all St. Paul parks. The Tobacco-Free Alliance is a nonprofit organization located in St. Paul, working in the Twin Cities to prevent youth from using commercial tobacco and to prioritize communities adversely affected by industry marketing and health disparities.

The City of St. Paul has long been at the forefront of implementing tobacco prevention policies to protect its residents, especially our children. St. Paul's parks are treasured communal spaces for everyone – children, families, individuals with respiratory conditions like asthma, the elderly, and those who simply wish to enjoy the outdoors without inhaling secondhand smoke, whether it be from cigarettes, vaping, or cannabis.

It is essential to recognize that restricting the use of these substances solely to designated youth activity areas within St. Paul's parks doesn't align with how these spaces are actually used. Children and youth freely explore all corners of the parks, making such a limited approach impractical and ineffective.

While Minnesota's recent cannabis law grants adults the right to use cannabis, the state legislature intentionally gave local governing bodies the authority to regulate public cannabis use, allowing them to tailor regulations to their communities' needs. If the legislature had intended to guarantee unrestricted public cannabis use, they would not have granted this authority to local governments to impose necessary restrictions. This delegation of power underscores the importance of local decision-making in preserving the health and well-being of the community's residents.

We urge you to vote for this policy without watering down its language. Your support will help ensure that every St. Paul resident can enjoy the parks and breathe clean air, free from the harm of secondhand smoke. This policy will make our outdoor spaces healthier and safer for everyone.

I am writing in support of regulating smoking in parks and on public property.

I am a long time resident of Saint Paul and a physician with Health Partners. Early in my career I worked to help make Minnesota's hospitals smoke-free. Today it is hard to imagine that anyone would smoke it a health care facility, but back then it was the norm. Some said you couldn't possibly ask expectant fathers not to smoke in the hospital. Well, yes, you can. And even expectant fathers can skip smoking. In fact, most expectant fathers and mothers don't smoke today.

Smoking rates have been pushed down mostly through public policies like ones that create a nonsmoking norm. Policies create an expectation for clean air for all. That is a huge public health win. It is a win that I as a physician cannot, in my entire career, expect to equal. In my practice I help people one patient at a time. As policy makers you help the whole community.

Because what you do impacts moms, dads, children, grandparents, college students, and everyone along the way it is critically important that you do the right thing in protecting all of us.

Please don't backslide on protecting the community from secondhand smoke. Support the smoke-free proposal before you.
