Dear Interested Parties:

This is to confirm that at the Legislative Hearing on July 25, 2023 Legislative Hearing Officer Marcia Moermond continued the matter to Legislative Hearing on **Tuesday**, **August 22**, **2023** at **9 am in room 330 City Hall/Court House for discussion of your bids, schedule, financing and affidavit** (see details below).

The \$5,000 Performance Deposit must be posted with the Department of Safety & Inspections by no later than close of business August 18, 2023. The Performance Deposit form can be found online here: https://www.stpaul.gov/departments/safety-inspections/vacant-buildings. Please contact the Department of Safety and Inspections directly at 651-266-8989 for questions regarding the application or payment process. This money is fully refundable upon completion of the project (or demolition, etc).

By noon on Monday, August 21 you must:

1. submit evidence of financing sufficient to complete the rehabilitation. Staff estimates costs to exceed \$75,000. If total for bids are more than 20% less than staff estimate, a high level of detail will be required. Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case by case basis.;



- 2. submit an affidavit indicating the **finances will be dedicated to completing the project** and not diverted until a code compliance certificate is issued; and
- **3. submit work plan, sworn construction statement, or scope of work.** This should include **signed** subcontractor bids and a **schedule** for completion of the project; and
- 4. the property must be maintained.
