The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **April 24, 2024** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code¹ (see footnote 1, below).

1. **RESIDENTIAL PARKING ON UNAPPROVED SURFACE:** All residential parking spaces shall be paved with asphalt, concrete or other suitable surfacing as determined by Zoning Enforcement. **CEASE PARKING ON UNAPPROVED SURFACES.** For information on installation of an approved parking surface contact Zoning Enforcement at **651.266-9008** regarding submittal and approval of a site plan.

PLEASE REMOVE THE VEHICLES, TRAILERS AND BOAT PARKING ON THE BACKYARD/LAWN. THANKS.

2. **COMMERCIAL VEHICLE:** Sec. 157.11. (d) Parking for larger vehicles: No commercial or overweight vehicle shall be parked overnight or stored on property zoned residential or occupied exclusively as residential.

PLEASE REMOVE THE COMMERCIAL VEHICLE FROM THE PROPERTY.
THANKS.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on or after **May 08, 2024**, by which date the violations noted must be corrected. Failure to correct these deficiencies may result in an abatement and/or additional fees for re-inspection.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal and pay a filing fee.)

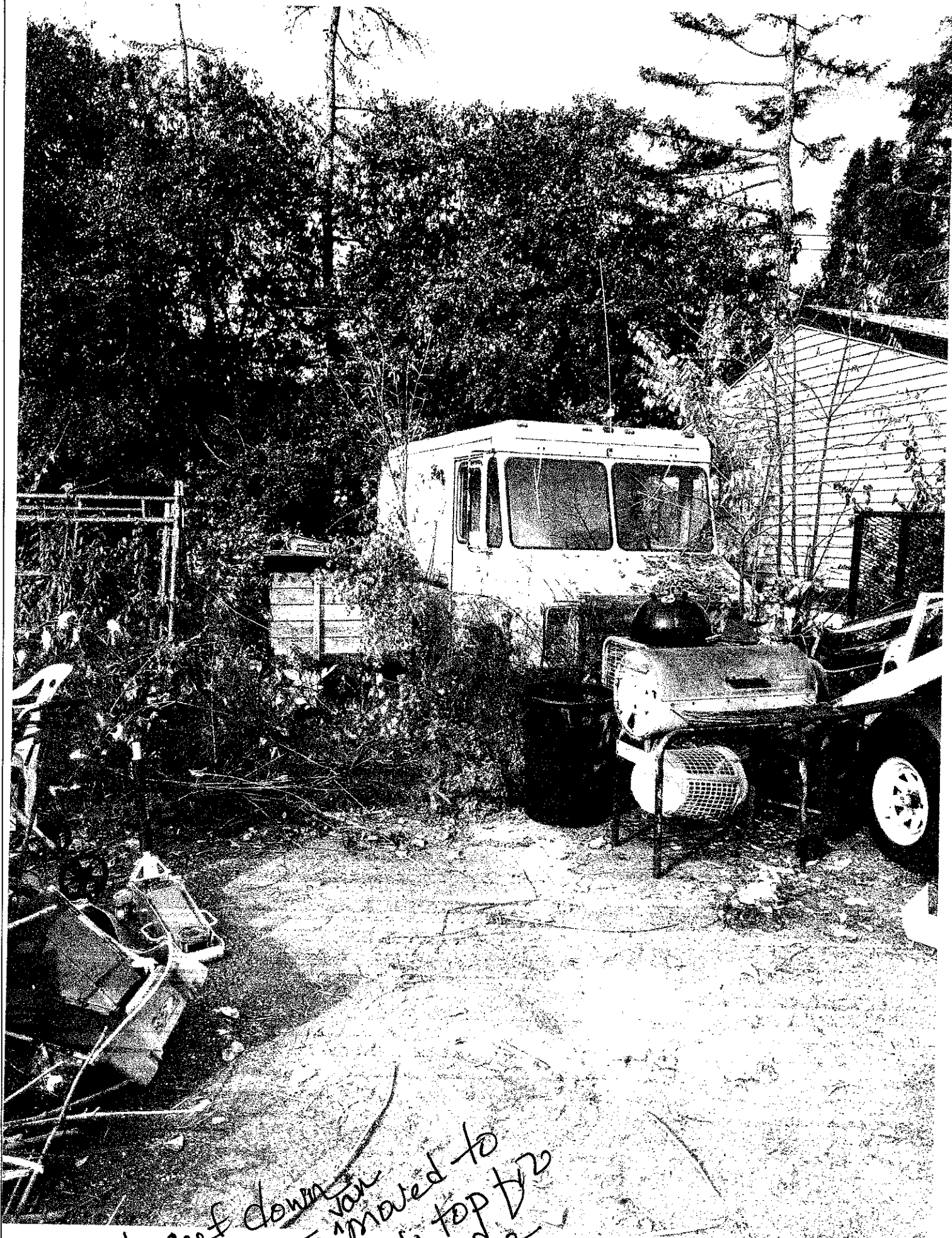

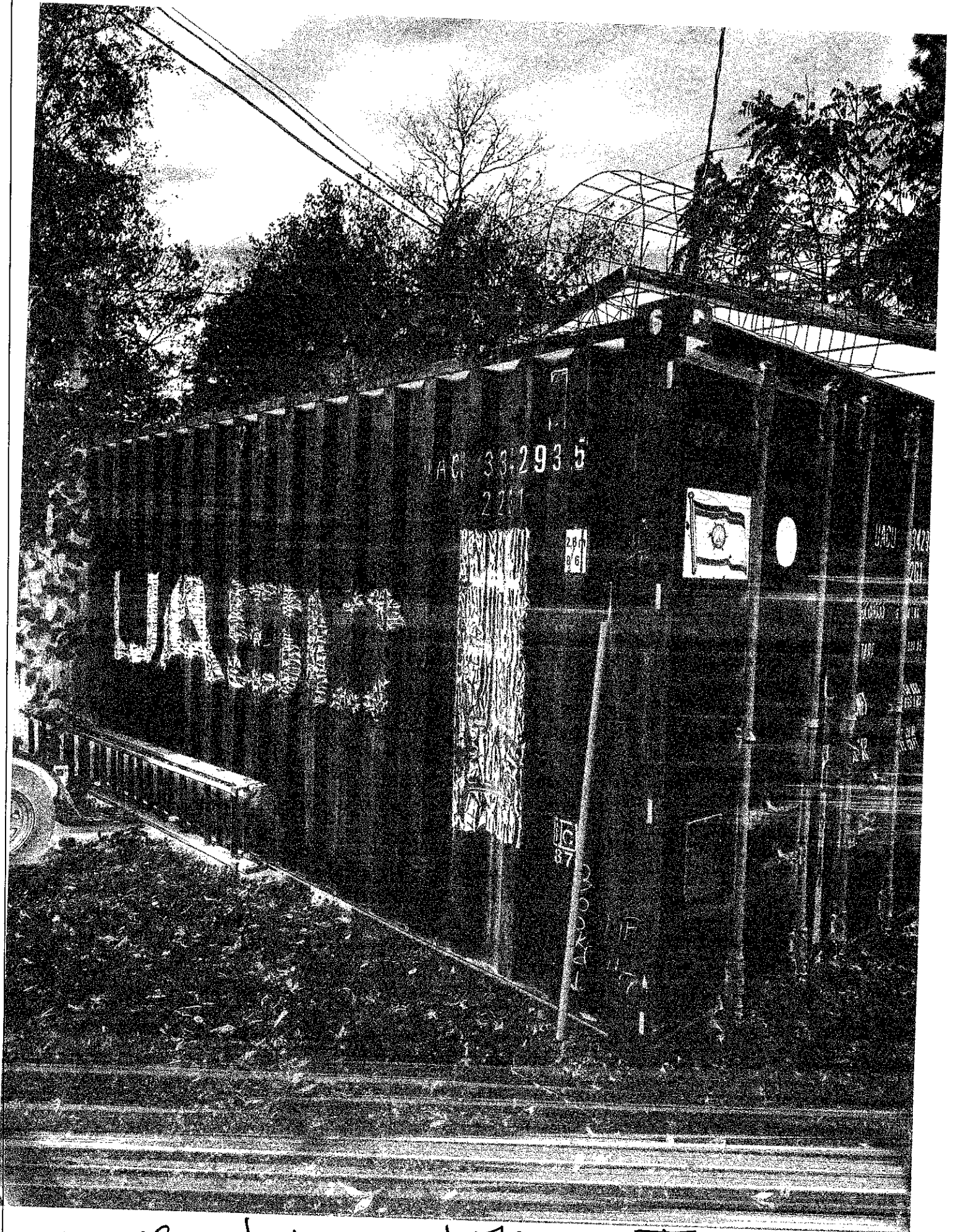
